Call to Order	Jones-Sutton called the meeting to order at 6:03pm. She welcomed Rubio-Cockroft to her first board meeting.	
Agenda Amendment	The twenty (20) year State Street Campus lease has been tabled. This allows the community additional time to ask questions and attend a State Street Campus tour. Work is continuing to complete the FAQ document.	
1. Approval of Minutes	Miller moved to accept the September 11, 2023, and October 3, 2023 minutes; seconded by Menefee. Motion carried.	
2. 2023-2024 Elections	Menefee nominated Amy Miller for the position of Woodlands Board Interim Treasurer; Miller accepted; seconded by Adams. Motion carried.	
3. Board Updates	Jones-Sutton provided updates on the potential merger of campuses: - A decision to delay the move by one (1) year has been made. - The twenty (20) year State Street Campus lease vote has been moved to the Annual Meeting. - A parent group, represented by an attorney, requested an exorbitant number of documents in an Open Records Request. The Woodland School attorney has been notified. The goal is for a meeting of the board and parent group to occur, addressing needs without continued legal representation.	

	 A petition, prepared by a parent group, has been reviewed. The board wishes to collaborate to discuss the mentioned concerns. Updates will continue to be added to the FAQ document. A concern about the petition was raised, as student names were present without permission. Brown-Gurley provided an update on the 2024-25 State Street lease. While a few changes are required, the lease will be a replicate, including the same rent, of the current year. 	
4. State Street Lease Vote	Miller moved to accept and sign the State Street Campus extension lease for the 2024-25 school year; seconded by Menefee. Motion carried.	
6. Open Comment	Numerous questions relative to the potential campus merger were posed. Jones-Sutton thanked the community for their questions and concerns, confirming that questions have been recorded and will be formally addressed in a FAQ document. For efficiency and accuracy of information, the FAQ will be posted to the website for review prior to January's Annual Meeting.
